a. Oracle Data Base Licenses – Mythics, Inc., *Mila Kofman, Executive Director*

Summary: With the DCAS Curam Upgrade scheduled for release on August 12th, 2016, and with the HBX 12-month SHOP conversion expansion project, the hardware/software needs of the DCAS project have grown and require new software license purchases. The project was bid out through the GSA schedule and the GSA-discounted pricing. Three bids were received. Mythics, Inc. was the lowest bid.
