Three Steps to Enrolling on DCHealthLink.com

- 1. Enter Information about You and Your Eligible Family Members
- 2. Compare <u>112 Plan Options</u> (Use <u>OPM Premium Contribution Calculator</u>)
- 3. Enroll in a Health Plan

Open Season is November 11th – December 9th

Late enrollments cannot be accepted


- <u>DCHealthLink.com</u> operates best using Google Chrome, Mozilla Firefox, or Safari web browsers. DO NOT use old versions of Internet Explorer.
- DO NOT use the back button on your web browser.
- DO NOT attempt to sign up prior to Open Season.
- To continue to receive your employer contribution, Members of Congress and designated staff must enroll in a health plan through DC Health Link no later than December 9th. There is no automatic enrollment.
- Before making your final selection, be sure you have reviewed all of your health plan options and checked the provider network coverage in your area.
