Meeting Minutes:

Trey Long opened the meeting with giving an overview of the ME&E work plan and the program code analysis spreadsheet. Arlene mentioned that the program codes are just for medical assistance. Sam asked about sunset codes...those codes that are currently not used. Arlene answered Sam's question by telling the group that she pulled all valid program codes to create the program code list. Because some codes are retired and some are still active, the idea was brought up to reconcile codes. DHCF and DHS are the agencies that will touch majority of the codes. Arlene "x" off the invalid codes. The "x" means that the codes cannot currently be used. According to Arlene, each number within the code represents something ex. the number 1 in the middle of the code represents people over the age of 65. Different agencies use the codes on a daily basis (CFSA) and other agencies use the codes as needed (DCOA).

Arlene told the group that the advantage of understanding codes is so that the groups can collapse coverage. The reason why there are so many program codes is because when there is a new group, you get a new code.

Agencies and Codes:

According to DHS, a DHS staffer goes to DCOA each Friday and works on coding and determines eligibility. Jolly Atkins with CFSA only touches about 6 codes. A representative from DHCF mentioned that all children could get a program code. All programs are based on the income threshold i.e. CHIP child vs. a TANF child. Poverty levels will change under healthcare reform; therefore, the program codes will be reduced. For Medicaid, there must be a service to receive a program code.

The program code spreadsheet should be updated with the following:

- Delivery of Service Methods (FFS, MCO, LTC)
- ACEDS Program Types (the 8 program types)
- Funding Stream

Before the meeting concluded, Arlene gave a demo of how to populate the program codes spreadsheet. Once the spreadsheet is updated and redistributed among the group, the members can then start to populate the spreadsheet. November 23rd, 2011 is the proposed date for completing the spreadsheet.

Other Information:

Office of State Superintendent of Education (OSSE) should be represented on the subcommittee.
