Sister Agency Survey

- Danielle provided an update on the process and results of the survey
- The presentation recapped a number of recommendations that have been captured in the DCAS requirements
- Questions:
 - Claudia asked about other agencies getting the reporting information they need from ACEDS – how will it work in DCAS?
 - Heather asked about data discrepancies between the MMIS and ACEDS, especially for kids. Deborah said that new and improved interfaces will be built between DCAS and the MMIS.
 - Deborah also talked about the need for data sharing agreements and further participation in the project

PMO Update

- Trey provided an update on the current requirements gathering work and upcoming activities
- Trey also described the additional work currently in progress, including the development of the Statement of Work (SOW) portion of the RFP and the IT portions of the Level II Grant

Schedule Update

- Trey provided an update on the revised scope of the releases and their timeframe.
 - All programs currently on ACEDS have been moved to Release 2 so that the legacy system can be retired earlier
 - The timeline for both release 2 and 3 was extended to account for additional complexity and more testing time
- During this discussion, Claudia mentioned that the District is still thinking about implementing the Basic Health Plan (BHP) with cost sharing (co-pays). That functionality would be part of Release 1. The E&E Work Group will follow up with Brie (the project manager for the Release 1 requirements) to discuss.
