Brokers must complete 4 hours of DC Health Link policy training that is specific to District laws and policies. Training will be provided both in person and online.

Carrier Appointments

Prior to registration with DC Health Link, a broker must obtain appointments with each carrier in DC Health Link for the market in which he/she intends to sell.

DC Health Link, carriers must appoint all brokers applying to sell health insurance through

DC Health Link.

Brokers will still need to ensure they meet the carrier requirements and provide copies where necessary for such items as their license, ade-As part of their agreement with quate E & O insurance coverage, broker contract/carrier agreement and all other necessary information.

QUIZ: Is this considered a Small Group?

Reminder: Small Businesses with 50 or fewer Full-Time Equivalent (FTE) employees are eligible to enroll.

You have a law firm that consists of 82 people. They

offer health insurance to all employees, as well as 12 retirees.

The group consists of:

- 30 partners (K-1's)
- 47 FTEs (W-2's)

• 5 contract staff (1099's)

YES. This is a small group with a total of 47 FTE's. The K-1's, 1099's and retirees are not included in the employer size calculation.
