

# **Policy Updates**



## **Individual Responsibility Requirement**

The federal mandate requiring individuals to have health coverage ended in 2018. On January 1, 2019, a new District of Columbia law went into effect requiring DC residents to have qualifying health coverage, qualify for an exemption, or pay a penalty on their DC taxes. This law is called the individual responsibility requirement.

To help consumers who may not know about this new law enroll in coverage and minimize their tax penalty, DC Health Link is offering a Special Enrollment Period (SEP) to uninsured DC residents who learn about the individual responsibility requirement while filing their 2018 taxes. Under this SEP, eligible residents can enroll in coverage through the Individual & Family market. This tip sheet lists specific questions your clients should be prepared to answer when contacting DC Health Link to learn about their options under this new SEP opportunity.

#### **Plan Match Integration**

It's now easier than ever for Employees to use Plan Match – DC Health Link's decision support tool powered by Consumers' CHECKBOOK. Employees who login to their DC Health Link account can now shop with their personal household information and Employer's contribution levels pre-populated in Plan Match. Once they select the plan that's right for them, Employees will be able complete plan enrollment. We began offering this option in the Individual & Family market in 2018 and are excited to extend it to Employees.

## **Enrollment Deadlines**



#### May 1 Coverage for Small Businesses

#### **Initial Groups**

- April 1
  - Last day to complete initial Employer application
- April 10
   Last day of Employee open enrollment period; invoices become available in the employer's account the first business day after Employee open enrollment closes
- April 12
   Last day to pay initial premium

## **Renewal Groups**

- April 5
  - Last day to complete Employer renewal application
- April 13
  - Last day of Employee open enrollment period
- Premium Payments
  - Deadline is listed on the mailed monthly invoice, which is also posted to the Employer's online account the first week of the month
