December 1 Coverage Effective Date:

- November 1 Last day to complete initial employer application
- November 10 Last day of employee open enrollment period and invoice is sent by email
- November 15 Last day to pay initial premium

January 1 Coverage Effective Date:

- December 1 Last day to complete initial employer application
- December 10 Last day of employee open enrollment period and invoice is sent by email
- December 13 Last day to pay initial premium

Renewal/Migration Groups

December 1 Coverage Effective Date: Deadlines extended

- November 10 Last day to complete employer renewal application
- November 15 Last day of employee open enrollment period

• Premium Payments — Continue to pay monthly invoice as received by mail. Migrating groups will receive the first invoice after the close of employee open enrollment.

January 1 Coverage Effective Date:

- December 5 Last day to complete employer renewal application
- December 13 Last day of employee open enrollment period
- Premium Payments Continue to pay monthly invoice as received by mail. Migrating groups will receive the first invoice after the close of employee open enrollment.

DC Health Link is in the process of automating our email services. When you receive responses after emailing <u>employer.hbx@dc.gov</u> there will be a reference code in the subject line. Please leave the reference code in the subject line to allow all of your communication to be kept together so your issues can be resolved in a timely manner.

Employee Open Enrollment Periods

DC Health Link recommends that employers and brokers leave employee open enrollment periods open as long as possible. The initial and renewal plan years provide default dates to give employees the most amount of time to make their plan selection after a group publishes the plan year. Groups do have the option to modify the end date of open enrollment prior to the posted

deadlines, however, concluding open enrollment prior to the deadline will not result in earlier transmission of files to the insurance companies by DC Health Link.
